1. THE PROMOTION

1. Information on how to enter and prizes form part of these Terms and Conditions. Entry in the Re-energize at the Red Centre Promotion (**Promotion**) is deemed acceptance of these Terms and Conditions.
2. The Promotion commences at 12:00am (AEDT), Saturday 19 March 2022 and closes at 11:59pm (AEDT), Sunday, 10 April 2022 (**Promotion Period**).
3. The Promotion is a game of chance.

2. PROMOTER'S DETAILS

The promoter is Red Energy Pty Limited (ABN 60 107 479 372) of 570 Church Street, Cremorne, Victoria 3121 (**Promoter**). The Promotion is authorised under NSW Permit No. TP/00236, SA Permit No. T22/345, ACT Permit No. TP22/00440.

3. ELIGIBILITY

1. Subject to clauses 3(2) and 3(3), entry in the Promotion is only open to residents in Victoria, New South Wales, South East Queensland, ACT or South Australia who are aged eighteen (18) years or over (**Eligible Entrant**). Any entries received by any person who is not an Eligible Entrant will be void.

3. Employees and their immediate families of the Australian Grand Prix Corporation (ABN 86 947 927 465) of Level 5, 616 St Kilda Road Melbourne 3000 and its subsidiaries or associates are not eligible to enter.

4. HOW TO ENTER THE PROMOTION

the offices of Anisimoff Legal at Suite 5 / 210 Central Coast Hwy, Erina NSW 2250 at 12:00pm AEST on Friday, 15 July 2022, subject to any written direction given under applicable law (**Re-Draw**). Any Prize Winner of an unclaimed Prize will be notified in the manner set out in clause 6(3). Any further draws that may be required to allocate any Prize that remain unclaimed following the redraw held on Friday, 15 July 2022 will be conducted in accordance with the instructions of the relevant State gaming authorities.
