



1. THE OFFER & PROMOTER

- (1) Subject to these Terms and Conditions, this "University of Newcastle \$50 Sign Up Credit" offer (**Offer**) is made by Red Energy Pty Limited ABN 60 107 479 382 of 570 Church Street, Cremorne, Victoria 3132 (**Red**).
- (2) The Offer commences at 8:00AM AEST on 12 February 2019 and is ongoing until the Offer is withdrawn under **clause 5(1)(a)(i) (Offer Period)**.

2. ELIGIBILITY & TAKING UP THE OFFER

- (1) Subject to **clause 2(2)**, this Offer is available to employees or contractors of University of Newcastle, who are 18 years or older and reside in Victoria, New South Wales, South Australia or South East Queensland and who are not existing residential customers of Red (**Eligible Participant**).
- (2) An Eligible Participant, who during the Offer Period:
 - (a) signs up their electricity supply to Red's 'Living Energy Saver, University of Newcastle Staff' offer product for a residential supply address in Victoria or New South Wales, or Red's 'Easy Saver, University of Newcastle Staff' offer product for a residential supply address in South Australia or South East Queensland by:
 - (i) requesting a call back on the dedicated University of Newcastle landing page at <https://www.redenergy.com.au/partner-offer/uon>; or
 - (ii) contacting Red in respect of the Offer and quotes 'University of Newcastle Offer'; and
 - (b) who do not cancel their electricity supply contract within their 10-business day cooling off period and Red subsequently becomes responsible for their electricity supply,will be eligible to receive one (1) x AUD50 (incl. GST) sign up credit (**Eligible Customer**), to be issued in accordance with **clause 3**.

3. \$50 SIGN UP CREDIT

- (1) An Eligible Customer will receive (1) x AUD50 (including GST) sign up credit to be applied to the Eligible Customer's electricity account with Red (**Sign Up Credit**). The Sign Up Credit will be applied to the Eligible Customer's electricity account prior to the issuance of the Eligible Customer's first electricity bill with Red.
- (2) There is a limit of one Sign Up Credit per Eligible Customer for each electricity account. If an Eligible Participant becomes an Eligible Customer for multiple residential addresses then the Eligible Customer will be eligible for a Sign Up Credit for each electricity account for each residential address.
- (3) The Sign Up Credit cannot be transferred, exchanged or redeemed for cash, even if the customer closes their electricity supply account with Red before they have exhausted their Sign Up Credit.

 - (c) to the extent permitted by law, will not be liable to any person for any cost, loss, damage, liability, personal injury or expense or claim arising, whether directly or indirectly, in connection with the Offer, including use of the Sign Up Credit.
