## 1. The Promotion

- (1) Information on how to enter and the Prize form part of these Terms and Conditions. Entry in the "Red Energy Roar and Snore Competition" (**Promotion**) is deemed acceptance of these Terms and Conditions.
- (2) The Promotion commences at 12:01am AEST, Monday 13 July 2020 and closes at 11:59pm AEDT, Monday 5 October 2020 (**Promotion Period**).
- (3) The Promotion is a game of chance.

## 2. Promoter's Details

## 3. Eligibility

- (3) The first valid entry drawn in each Prize Draw will win the Prize (**Prize Winner**).
