Terms and Conditions (as at 20 May 2026)



1. The Promotion

- (1) Information on how to enter and prizes form part of these Terms and Conditions. Entry in the win 100,000 Qantas Points Promotion (**Promotion**) is deemed acceptance of these Terms and Conditions.
- (2) The Promotion commences at 12:01am AEST, Monday 1 June 2026 and closes at 11:59pm AEST, Tuesday 28 July 2026 (**Promotion Period**).
- (3) The Promotion is a game of chance.

2. Promoter's Details

The promoter is Red Energy Pty Limited (ABN 60 107 479 372) of 570 Church Street, Cremorne, Victoria 3121 (**Promoter**). The Promotion is authorised under NSW Permit No. TP/00236, SA Permit No. T26/717, ACT Permit No. TP 26/00934.

3. Eligibility

- (1) Subject to **clauses 3(2) and 3(3)**, entry in the Promotion is open to:

 - (2) has linked their plan with their Qantas Frequent Flyer or Qantas Business Rewards account; or
 - (b) any existing customer of the Promoter who is 18 years or older who is on a residential or business Qantas Red plan as at the commencement of the Promotion Period; and
 - (1) is a Qantas Frequent Flyer or Qantas Business Rewards member; and
 - (2) has linked their plan with their Qantas Frequent Flyer or Qantas Business Rewards account

(Qantas Red Eligible Entrant); or

- (c) any customer of the Promoter aged 18 years or older who has signed up to a residential or business Qantas Red plan during the Promotion Period or as at the commencement of the Promotion Period is on a current residential or business Qantas Red plan; and
 - (1) is a Qantas Frequent Flyer or Qantas Business Rewards member; and
 - (2) has linked their plan with their Qantas Frequent Flyer or Qantas Business Rewards account; and
 - (3) is eligible to earn points for paying their residential energy bills on time or business energy bills in full;

AND

whose full name and account number was quoted during sign up or within 5 business days of sign up and during the Promotion Period by a new residential or business customer or returning residential or business customer that has not held an active electricity or gas account with the Promoter at any time within the

immediately preceding twenty-four (24) months who owns a business located in or is a Victorian, New South Wales, South Australian, Queensland or Australian Capital Territory resident aged 18 years or over, and who remains a customer as at the end of the Promotion Period, (**Referral Eligible Entrant**).

- (2) Employees and their immediate families of the Promoter and Qantas Airways Limited and their affiliates and subsidiaries are not eligible to enter.
- (3) The Promoter reserves the right to verify the validity of each entry. The Promoter reserves the right to disqualify any person for tampering with the entry process or who otherwise does not comply with these Terms and Conditions.

4. How to Enter into the Promotion

- (1) Each **Qantas Red Eligible Entrant** will be automatically placed into:
 - (a) if they are a new customer who has signed up to Red Energy on a residential or business Qantas Red plan, or are an existing customer who has signed up a new property on a residential or business Qantas Red Plan during the Promotion Period, the Daily Prize Draw for the date on which they signed up to Red Energy and either the Last Chance Prize Draw Qantas Frequent Flyer or the Last Chance Prize Draw Qantas Business Rewards; or
 - (b) if they are an existing customer who is on a residential or business Qantas Red plan as at the commencement of the Promotion Period, the Last Chance Prize Draw;

to be held in accordance with **clause 6**. A Qantas Red Eligible Entrant who is entered into a Prize Draw will be a “Qantas Red Entrant”. For the avoidance of doubt, a Qantas Red Entrant will receive one (1) entry into the applicable Daily Prize Draw and/or relevant Last Chance Prize Draw.

- (2) Each **Referral Eligible Entrant** at the end of the Promotion Period will automatically be placed into either the Last Chance Prize Draw Qantas Frequent Flyer or Last Chance Prize Draw Qantas Business Rewards to be held in accordance with **clause 6**. A Referral Eligible Entrant who is entered into the Last Chance Prize Draw will be a “Referral Entrant”. For the avoidance of doubt, a Referral Entrant will receive one (1) automatic entry into the relevant Last Chance Prize Draw and then five (5) additional entries into either the Last Chance Prize Draw Qantas Frequent Flyer or Last Chance Prize Draw Qantas Business Rewards for every successful Referral. 5. The Prize

(Prizes).
